- 1) Tea Industry being seasonal in character, results of the Company for the part of the year (which includes results of Tea Division) cannot be taken as indicative of results of the full year.
- 2) In view of note 1 above, the Taxable profit for the year is unascertainable at present and hence Provision for Taxation both current and deferred for the current year will be considered at the year end which has been reported by the Auditors in their Review Report.
- 3) The above results, as reviewed and recommended by the Audit Committee, was approved by the Board of Directors at their respective meetings held on 14th August, 2014, and the Statutory Auditors has carried out the 'Limited Review' as required under Clause 41 of the Listing Agreement.
- 4) The figures for the quarter ended 31st March 2014 are the balancing figures between the audited figures in respect of the full financial year and the year to date figures up to the third quarter ended 31st December 2013.
- 5) The company has set up a Wholly Owned Subsidiary, Gillanders Holdings (Mauritius) Limited, at Mauritius for the purpose of overseas acquisitions and investment.
- 6) Pursuant to applicability of the Companies Act, 2013 ("the Act") with effect from April 1, 2014, the Company has re-worked depreciation with reference to the economic useful life of its fixed assets as prescribed by Schedule-II of the Act or re-assessed by the Company based on technical evaluation. Consequently, the depreciation for the quarter ended 30th June, 2014 is lower by ₹ 172.34 lakhs and an amount of ₹ 242.32 lakhs (net of deferred tax) is recognised in the opening balance of retained earnings where the remaining useful life of the assets is exhausted.
- 7) Previous period's/year figures have been rearranged and/or regrouped, wherever necessary.
