- 1. In terms of the order dated 22nd August, 2016 of the Hon'ble High Court at Calcutta I was appointed by Gillanders Arbuthnot and Company Limited having CIN: L51909WB1935PLC008194 (herein after referred to as the 'Company') to be the Scrutinizer for the purpose of scrutinizing the voting on the following resolution:-

- 2.
