

Transfer of Ordinary Shares of the Company to the Investor Education and Protection Fund (IEPF)

Members are hereby informed that pursuant to the provisions of Section 124(5) of the Companies Act, 2013, read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Related) Rules, 2010 (IEPF Rules), as extended from time to time, all shares in respect of which dividend has not been paid or claimed for 7 (seven) consecutive years should be transferred to IEPF.
