The remote e-voting shall not be allowed beyond the said date and time.

A person, whose name appears in the register of members / beneficial owners as on the cut-off date i.e. Friday, 7th August, 2020 only shall be entitled to avail the facility of remote e-voting or e-voting at the 86th AGM. This manner of remote e-voting for members holding shares in electronic mode, physical mode and for the members who have not registered their e-mail addresses is provided in the Notice convening the 86th AGM.
