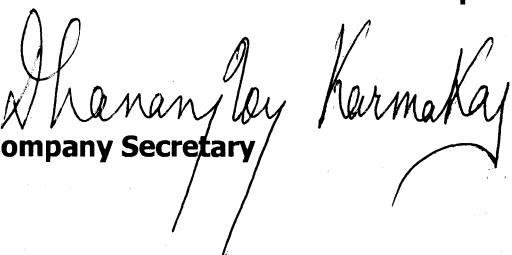

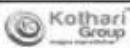

NOTICE TO MEMBERS

Notice is hereby given that pursuant to Sections 10B, 11D and other applicable provisions, Fany, of the Companies Act, 2013 ('the Act'), read together with the Companies (Management and Administration) Rules, 2014 ('the Rules'), Secretarial Standard on General Meetings (SS-2) and Regulation 47 of SEM (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('the Listing Regulations') (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), General Circular No. 14/2020 dated 8th April, 2020 and General Circular No. 17/2020 dated 13th April, 2020 and General Circular No. 22/2020 dated 15th June, 2020 ('the MCA Circulars') and any other applicable laws and regulations, the Company is seeking approval of the Members by way of Postal Ballot (only through remote e-voting) for the business as set out in the Postal Ballot Notice ('Notice') dated 14th August, 2020 together with the Explanatory Statement as contained in the Notice.

The Company is pleased to offer to its Members the facility to cast their vote by electronic means through e-voting facility provided by Central Depository Services (India) Limited ('CDSL') in compliance with the Sections 108 and 110 of the Act read with the Rules framed thereunder and Regulation 44 of the Listing Regulations.

The Company has on 21st August, 2020 sent the Notice by e-mail only to those Members who have registered their e-mail addresses with the Company or with their respective depository participants. In view of the current scenario of COVID-19 pandemic and in compliance with the MCA Circulars, hard copy of Notice along with Postal Ballot Forms and pre-paid business reply envelope will not be sent to the Members for this Postal Ballot and Members are requested to communicate their absent or dissent through the remote voting system only.

Members holding shares in dematerialized form and who have not registered their e-mail addresses are requested to update / register the same with their respective Depository Participant(s) and members holding shares in physical form are requested to update / register their e-mail addresses as detailed in the Notice.

The e-voting period commences Saturday, 22nd August, 2020 at 9:00 AM and ends on Sunday, 20th September, 2020 at 5:00 P.M. During this period, Members of the Company, holding shares as on 14th August, 2020 ('the cut-off date') may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter and the voting shall not be allowed beyond the said date and time. Once the vote on the Special Resolution is exercised and confirmed by the Members, he or she shall not be allowed to modify it subsequently. Recipient of the Notice, who was not a Member as on cut-off date, should treat the Notice for information purpose only.

The voting rights of the Members shall be in proportion to their shares of the paid-up equity share capital of the Company as on cut-off date.

The Company may also display the results of the postal ballot at its registered office.

The last date specified by the Company for remote e-voting shall be the date on which the Resolution shall be deemed to have been passed, if convened.
